


I, PHILIP SHARPE having been elected as a council member of the PARISH OF NAFFERTON

1. A person elected to the office of Parish Councillor shall make the above Declaration before or at the first meeting of the Parish Council after their election or, if the Council at that meeting so permit, before or at a later meeting of the council
2. The Declaration shall be made in the presence of a member of the Parish Council or the Clerk to the Parish Council and signed by that person at (a) or (b) above
3. The completed Declaration must be handed to the Clerk of the Parish Council for their retention immediately after completion. A copy should be sent to the Democratic Services Manager at County Hall, Beverley HU17 9BA
4. If an elected member of the Parish Council fails to comply with 1 and 2 above, their office shall become vacant.

- C. Any contact which is made between any of the above named persons (or a body in which any of the above named persons have a beneficial interest") and the authority under which goods or services are to be provided or works are to be executed, and which has not been fully discharged.

*Body in which any of the above persons has a beneficial interest means a firm in which any of the above names persons is a partner or a body corporate of which any of the above named persons is a director, or in the securities of which any of the above named persons has a beneficial interest

- D. Any beneficial interest in land which is within the area of the authority
