## The Localism Act 2011 The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

### Notification by a Member of Disclosable Pecuniary and Non-Pecuniary Interests

**NB** - In accordance with Section 34 of the Localism Act 2011, a person commits an offence if, without reasonable excuse, they fail to register their pecuniary interests within 28 days of taking office or fail to update their register within 28 days of a change to their pecuniary interests.
